Important Conditions to the Candidates :

1. The RTP Registration is done as per the provisions made in the Appendix-II of the Assam Unified Building Construction (Regulation) Byelaws, 2022 against the applications received in the prescribed format (Form-4 or 5; as the case may be) from the individuals and groups of agencies of Architect(s)/Engineer(s)/Structural Engineer(s)/Supervisor(s)/ Town Planner(s)/Landscape Architect(s)/Urban Designer(s)/Engineer for Utility Services/Geo-Technical Engineer(s) whose qualifications and competence satisfy the Appendix-II of the Assam Unified Building Construction (Regulation) Byelaws, 2022 and registered the incumbents will be responsible for carrying out the services as per the provision of the said Bye Laws as Competent Registered Technical Personnel (RTP) in Assam.
2. The Authority reserves exclusive right to declare black listed, cancel registration or take any other action that the Authority may decide to take against the defaulting RTPs as per the clause A-7 under Appendix-II of the Assam Unified Building Construction (Regulation) Byelaws, 2022.
3. The RTPs shall carry out the professional practice as per the provisions made under Assam Unified Building Construction (Regulation) Byelaws, 2022.
4. In case of any proprietor of a Group/Agency is not a Technical Person then the Drawings (Architectural/Engineering/Structural etc.) shall be signed by the concerned Technical Expert(s) of the Organization with proper educational qualification. In case of change in the concerned Technical Expert, the proprietor of the Group shall immediately intimate the same to the Director, Town and Country Planning Assam.
5. The RTPs shall submit the applications for renewal of their registration numbers before 45 (forty five) days from the date of expiry of the validity period at the Office of the Director, Town and Country Planning Assam.
