It is notified that the final Master Plan and the Zoning Regulation for Nowgong prepared by the Town Planner and Ex-Officio Director of Town and Country Planning, Government of Assam and adopted by the State Government under Section (10) (2) of the Assam Town and Country Planning Act, 1959 read with Section 3(2) of the Assam Town and Country Planning (Amendment) Act, 1962 for the area described in the Schedule below is hereby published.
