1. It is notified that the Modified Final Master Plan and Zoning Regulations for Tinsukia prepared by the Director of Town & Country Planning, Government of Assam and adopted by the State Govt. under Section 10 (2) of the Assam Town & Country Planning Act, 1959 d with Section 3 (2) of the Assam Town & Country Planning (amendment) Act 1962 for the area described in the Schedule in Map is hereby published.

The Modified Final Master Plan and the Zoning Regulations together with all relevant papers and maps may be inspected free of cost during office hours at the office of the Director, Town & Country Planning, Govt. of Assam Dispur, Guwahati-6; Executive Engineer, Drainage & Sewerage Division, Town & Country Planning, Tinsukia; the Chairman; Tinsukia Development Authority; Deputy Commissioner, Tinsukia District, Tinsukia; and the Chairman, Tinsukia Municipality, Tinsukia. 1. 1. INTRODUCTION:
